# **Hamlin Park Court Renovation**

The Skokie Park District does hereby invite sealed bids for the Hamlin Park Court Renovation. Work will include removals, earthwork operations, asphalt paving, color coating and striping, sports equipment fencing, and seeding.

Bidding documents are available to download and print at the non-refundable cost of reproduction.

Bids will be accepted at the Skokie Park District Park Services Center, 7500 Frontage Road, Skokie, Illinois 60077 during regular office hours. All bids must be submitted in a sealed envelope marked with the Contractor's name and address, and "Bid for Hamlin Park Court Renovation," on the face of the envelope. Bids must be received no later than May 6, 2021, 10:00 AM. Bids will be opened on May 6, 2021, 10:01 AM at the Skokie Park District Park Services Center, 7500 Frontage Road, Skokie, Illinois 60077. All bidders will be required to submit Bid Security in the form of a Bid Bond in the amount of 10% of the Base Bid, payable to the Skokie Park District.

The successful bidder, as determined by the Skokie Park District, shall be required to pay, and to agree to pay no less than the Prevailing Rate of Wages, pursuant to the Illinois Prevailing Wage Act (820 ILCS 130) for the locality of the Skokie Park District (Cook County), to each laborer worker, or mechanic needed or used to complete the work as detailed in the contract to be let. The successful contractor, and all subcontractors shall be required to submit, to the Skokie Park District, certified payrolls no later than the tenth day of each calendar month for the immediately preceding month.

The Skokie Park District reserves the right to reject any and all proposals, parts of any and all proposals, or to waive technical errors or omissions in submitted proposals. No submitted bid may be withdrawn until a period of sixty (60) days after the bid opening date, without written consent of the Skokie Park District. The Skokie Park District encourages minority business firms to submit bids on this project and the successful contract bidder to utilize minority businesses as sub-contractors for supplies, equipment, services, and construction.
