FOOTGOLF Guidelines & Restrictions (as of 6/11/2021)

We expect those who play Weber Park Golf Course to follow all of these guidelines and restrictions. Disregarding these may result in removal of players or force the closure of the golf course. We ask all of you to be respectful of others and follow the procedures listed below.

New Facial Masks Guidelines

Effective immediately the park district will operate under the following guidelines:

Staff and participants who are VACCINATED

- Masks are not required outdoors, but should be worn when social distancing is not possible when interacting with children ages 0-11.
- Masks are required indoors and on buses if involved with a program/camp that serves children (ages 0-11) who are not yet eligible to be vaccinated.
- Masks are not required indoors if involved with a program that serves children/adults (ages 12+) who are eligible to be vaccinated.

Staff and participants who are NOT VACCINATED

- Masks are not required outdoors if social distancing is consistently attainable. Masks should be worn when social distancing is not possible.
- Masks are required indoors and on buses.

Programs and Facilities that Still Require Masks

The state indicates that individuals in schools, day care settings, and educational institutions should continue to follow separate guidance issued by the Illinois State Board of Education, Illinois Department of Family Services (DCFS), and the Illinois Department of Public Health.

Masks are required at the facilities and in the programs listed below.

Not Vaccinated?

Skokie residents age 12 and older, and employees at Skokie businesses are invited to sign up to receive a free COVID-19 vaccination from the Village of Skokie. Information on Village clinics will be posted when scheduled, with the next first-dose clinics expected to occur during the week of May 31. Village of Skokie offers vaccines to residents and workers.

Tee-Times Required – Walk-Ups Accepted with Availability

Tee time reservations are still required for ALL footgolfers. Walk-ups will be accepted as long as open tee times are available. Expect the following:

- **Do not book a tee time or come to the golf course if you have any symptoms of COVID-19 or someone in your household has symptoms of COVID-19.**
- Call the pro shop at 847.674.1500 ext. 3600 to book your tee time. Reservations are taken from 7 AM to 5 PM.
- Book your tee time at least 24 hours and no earlier than 7 days in advanced.
- Walk-ups allowed based on availability and will be assigned the first available tee time.
- Foursomes will be permitted.
- 12 minutes between tee-times.
- First tee time is 8 AM with the last tee time of the day 1.5 hours before sunset. Gates are locked promptly at or prior to sunset based on usage.

Day of your round:

- Please arrive about 5-10 minutes prior to your tee time.
- **Upon arrival, check in with the golf shop and make payment for your round. Contactless payments only – NO CASH. Visa, Mastercard and Discover are accepted. All pass holders must check in at the golf shop and present your Skokie Park District picture ID to the cashier. Make sure you receive a receipt as it will be required at the first tee.**
- Check-in with the starter at the first tee and show your receipt prior to stepping up to the tee.
- Bring your own #5 soccer ball. Ball rentals are NOT available.
- If you are sick, feeling sick or have a fever do not come to the golf course. Call the pro shop to inform them.

Resident / Senior Rates – if you are a Skokie resident a valid ID showing proof address will be required at check-in. No senior rates are available for FootGolf.

Replays - if you plan to replay the course after your initial round, book it at the same time of your first round. Allow enough time between rounds.

Rain checks – should the weather force the closure of the golf course or if conditions become severely inclement, rain checks will be issued. **NO REFUNDS.**

Cancellations – If you must cancel your tee time a minimum of 24 hours is required. Call 847.674.1500, ext. 3600 to cancel your tee time.

10-play pass holders – you must book a tee time prior to your round. No tee time fees will apply.

Player Restrictions & Expectations

- The pro shop along with the building are open. The indoor restrooms available.
- The portable restroom on hole #4 is available.
- For fully vaccinated individuals, facial masks and socially distancing are not required.
- If you have NOT been vaccinated, facial covering and social distancing are still required. However, facial coverings will not be necessary while playing as long as social distancing is maintained.
- Each FootGolfer should pick up and touch only their own ball.
- It is recommended you bring your own #5 soccer ball. Avoid touching any balls other than your own.
- Ball sharing is not recommended.
- Bring your own water/sports drink, towel, and snacks. **ALL ALCOHOLIC BEVERAGES AND ILLEGAL SUBSTANCES ARE NOT PERMITTED.**
- Observe pace of play – keep pace. **8** stroke limit per hole.
- Follow all posted signs and observe all local rules. DO NOT play the course out of order.
- Pencils and scorecards will be available.
- DO NOT KICK OR PLAY ON OR OFF ANY OF THE REGULAR GOLF COURSE PUTTING GREENS. Take a free drop 10 feet from the edge of the green and continue. Refer to the scorecard for further rules.
- Public access to the gazebo will not be available.
- Wash your hands thoroughly as soon as you can after leaving the golf course – we recommend bringing your own hand sanitizer and using it at least prior, during and after your round.
- Maintain social distancing and wear masks as required when on the patio.
- After your round, do not shake hands and please go home. Do not congregate in the parking lot.
